## ENGAGEMENT AGREEMENT

## اتفاقية خدمات

This **ENGAGEMENT AGREEMENT** ("Agreement") is effective this October 01, 2018 (the "Effective Date"), by and between the Muslim World League (MWL), with headquarters at Makkah Al-Mukarramah - Omm al Joud, Old Jeddah Road, PO BOX 537, Kingdom of Saudi Arabia ("Client") and the Saudi American Public Relation Affairs Committee, Inc. ("SAPRAC") with office at 1101 30th Street NW, Suite 315, Washington DC 20007 ("Provider"). The Client and the Provider are hereinafter referred to collectively as the "Parties" and separately as a "Party."

**WHEREAS**, Client and Provider wish to memorialize the terms and conditions set forth herein and formalize their agreement to have the Provider perform the Services, as hereinafter defined; and **WHEREAS**, the Provider is willing to perform the Services and the Client is willing to pay for the Services, as set forth herein.

**NOW THEREFORE**, the Parties hereby agree to the recitals set forth above and to the following:

### 1. Services

The Provider shall perform Services set forth in this agreement, and such additional services, if any, as shall be agreed upon by the Parties in writing (the "Services"). SAPRAC will provide the following services during the Second Annual Conference on Cultural Rapprochement between the United States and the Islamic world, on 4-5 October, 2018: 1) provide American and international mainstream media and social media coverage, 2) organize and facilitate senior officials and speakers for the conference, 3) provide consulting on keynote speeches and points of

**الآن وبناءً على ذلك**، توافق الأطراف بموجبه على القرارات المذكورة أعلاه وعلى ما يلي:

### ١. الخدمات

يجب أن يقوم مقدم الخدمة بتنفيذ الخدمات المنصوص عليها في هذه الاتفاقية وكذلك أي خدمات إضافية، إن وجدت، حسبما يتفق عليه الطرفان كتابة "الخدمات". ستقوم سابرak بتقديم الخدمات التالية خلال المؤتمر السنوي الثاني حول التقارب الثقافي بين الولايات المتحدة والعالم الإسلامي، من ٤ إلى ٥ أكتوبر ٢٠١٨: (١) توفير تغطية وسائل الإعلام الأمريكية والدولية الرئيسية للتغطية الإعلامية والاجتماعية، (٢) تنظيم وتوفير كبار المسؤولين والمتحدثين في المؤتمر، (٣) تقديم الاستشارات حول الخطابات الرئيسية ونقاط الحوار إلى معالي الشيخ الدكتور محمد العيسى، و (٤) تقديم خدمات الترجمة خلال الاجتماعات

dialogue to His Excellency Dr. Mohammed Al-Issa, and 4) provid translation services during private meetings for His Excellency Sheikh Dr. Mohammad Al-Issa. Nothing contained in this Agreement shall be construed as a guarantee or warranty, either express or implied, on the part of either Party that any of the meetings, engagements and media coverage facilitated by the Provider will meet their goals, timelines or budgets or yield the outcomes expected by the Client.

## 2. Payment

For the Services, the Client shall pay the Provider a one-time fee of Thirty five Thousand Dollars (\$135,000). The payment shall include all of the Services set forth, not including the out-of-pocket expenses. This payment is due upon execution of this agreement and the Provider will not commence services until payment is received.

The duly authorized representatives of the Parties, agreeing to be bound hereby, have executed this Agreement as of the Effective Date:
