SAPRAC arranged for the Secretary General of the MWL Dr. al-Issa to be the featured guest of honor at the Museum of Jewish Heritage in New York City hosted by the Conference of Presidents to commemorate the Holocaust and emphasize the importance of Muslim and Jewish interfaith relations during a time when anti-semitism is increasingly apparent in the international community.

SAPRAC also organized meetings between the MWL delegation and U.S. Department of State officials, including Ambassador At-Large for International Religious Freedom Sam Brownback, detailing efforts taken by the MWL that correlate to uphold U.S. policy goals of promoting religious tolerance and counter-extremism efforts.
