Activities and Services for the Council during Period May 01, 2020 to October 31, 2020: The COVID-19 pandemic drastically changed my activities and services for the KBE Local Government Council. I did no travel, or in-person contacts with anyone representing the U.S. Government during this time. However, I did submit two applications for Technical Assistance grants to the Office of Insular Affairs in the Department of the Interior. The Technical Assistance grants are available on a competitive basis on applications from entities in the Freely Associated States. Most of my activities were involving the remote management of the KBE Local Government projects and programs in the Marshall Islands, and legal issues and cases in the Marshall Islands courts. No one from the KBE Local Government traveled to the United States to meet with or lobby anyone in the U.S. Government as there are no flights in or out of the Marshall Islands at this time, as the Marshall Islands attempts, successfully so far, to keep its nation COVID-19 free.

As mentioned above, I assisted the KBE Local Government Authority in submitting two applications for Technical Assistance grants administered by the Office of Insular Affairs in the Department of the Interior. This involved completing the application online and submitting it online to the Office of Insular Affairs. I don't think this is "political activity" as this is more nuts and bolts grant request that is available and shared among all entities in the Freely Associated States, who also compete for these grants.
