Khaled Hifter, I provided strategic consulting, advocacy and public relations concept guidance to/for my client. In addition, communicated with Capitol Hill directly, as well as sent out press releases providing my client's narratives and desires/intents to serve the citizens of Libya.

Southern Transitional Council, I provided strategic guidance and assisted with vendor relationships (legal, accounting, etc.). In addition, sent out press releases and media interviews, as well as communications on behalf of my client with Capitol Hill to further the goals/intents of STC soliciting support for the citizens of South Yemen.

On behalf of Khaled Hifter, I worked to set up a Capitol Hill briefing event via communication with U.S. Rep. Gosar's (as well as emailing to U.S. Rep Poe, Hunter) staff in March 2018. Due to logistical issues, we had to postpone this event. I also contacted US HFAC Committee staff on 4/18/18 to correct the false narratives regarding the health of Gen. Khalifa Hifter, and about his activities in Libya, this was done via email. As far as press, I sent out press releases via PR Newswire on 12/8/2017, 12/22/2017 regarding the work of Gen. Hifter and the LNA goals/intents in Libya, which was sent to FARA as disseminated information.

On behalf of the STC, I contacted the staff of U.S. Rep Rutherford to assist with guidance in selecting a room for a Capitol Hill briefing (3/2, 3/12, 3/14, 3/21, 3/27 and 4/15/18). In addition, sent out press releases via PR Newswire on 2/3/2018 to reflect the goals/intent of STC in representing the citizens of South Yemen.


