ANO TV-Novosti. Registrant produces news and talk show television programs. The programs are predominantly distributed by ANO TV-Novosti. The activities of T&R Productions entail routine journalistic efforts of filming and producing television shows. T&R Productions LLC believes it does not contact U.S. government officials or U.S. media representatives to lobby them about U.S. Government policies or interests or the policies or interests of any foreign government.
