Registrant provided strategic communications support and guidance in furtherance of the interests of the Embassy of the United Arab Emirates, with an emphasis on strengthening bilateral relations and regional security of the United Arab Emirates, in particular including issues relating to client's termination of relations with Qatar and accuracy and transparency of Qatar government-owned media. Activities and support engaged in by the registrant in furtherance of these efforts included one-on-one interactions with members of the news media in the United States to support and promote the aforementioned interests of the Embassy of the United Arab Emirates.
