Ms. Alderisi expects to be a candidate for a seat that represents Italian nationals who are registered voters in Italy but who are resident in North and Central America. The registrant will not be compensated or reimbursed for its efforts. The agreement/understanding will end at the close of Italy's elections in March, 2018.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The registrant expects to engage in a number of outreach efforts directed at registered Italian voters living in North and Central America to further Ms. Alderisi's candidacy.

If yes, describe all such political activities indicating, among other things, the relations, interests or policies to be influenced together with the means to be employed to achieve this purpose.

The registrant's activities will be focused on the candidacy of Ms. Alderisi for election in Italy. In that regard, neither U.S. domestic nor foreign policies will be involved. However, the political or public interests and policies of Italy will be involved. The effort will be to influence only Italian nationals registered to vote in Italian elections.
