The principal, Felix Tshisekedi has requested the assistance of the registrant in organizing meetings between Mr. Tshisekedi and representatives of the State Department both in Washington, D.C. and at the United States Mission to the United Nations in New York City. There will be no payment to the registrant for their work in this respect.

The registrant has initiated contact with officials of the State Department for the purpose of organizing meetings between the State Department and Felix Tshisekedi and between the United States Mission to the United Nations and Felix Tshisekedi.
