Activities on behalf of foreign principal: Drafting of language of the resolution based on content found through our research that will be most politically favorable to both parties in the Senate with input from representative of the Kurdish Regional Government to call for a convening of an international donor conference in support of the Kurdistan Region of Iraq's humanitarian challenges. Directly contacting offices of each Committee member to gauge support or resistance to the resolution.
