Statement of Work

This Statement of Work ("SOW") is by and between ThirdCircle ("TC") and Embassy of Morocco ("EOM")

Effective Date: This SOW is effective as of January 1, 2018.

Scope of Work: TC will work with EOM and other relevant parties to craft an outreach program to provide opportunities to engage in meaningful dialogue with various stakeholder and ethnic/issue-oriented groups across a range of issues from culture to economics. In addition, TC will also focus on promoting Morocco as a film destination, bringing US film and television producers to Morocco and providing opportunities for Moroccan producers and others to meet with relevant studios and production companies in the US. Lastly, TC will highlight Morocco as a world-class golf destination, bringing golf professionals and other professional athletes, celebrities and golf enthusiasts – including media like the Golf Channel and others – from around the world to experience the majestic golf courses that span the country: from Rabat to Marrakech and elsewhere.

Terms: TC will be paid \$40,000 USD monthly for the next twelve (12) months with payments made in advance on a quarterly basis. This SOW can be extended for another twelve (12) months upon written agreement by the parties. Either party may cancel this agreement with sixty (60) days written notice. All fees incurred up until that point will be payable to TC. Any expenses incurred on behalf of EOM will be billed separately and will be reimbursed fully by EOM. Expenses over \$300 will be pre-approved by EOM.

Any air/train travel will be in Business Class.

In addition, any legal fees/costs incurred to ensure full compliance with existing US laws and regulations will be the financial responsibility of EOM.


