Article 3. Investigations into the Entrusted Project

- The Consignor can, when it deems necessary, make enquiries to the Consignee or request

petition in bankruptcy or insolvency, the appointment of receiver, an assignment on behalf of its creditors or any other similar proceeding.

- In the event that this agreement is terminated in accordance with the preceding paragraph, any and all obligations of the Consignee shall immediately become due and payable to the Consignor.

Article 12. Governing Law and Jurisdiction

- This agreement shall be governed by and construed in accordance with the laws of Japan.
- The parties hereby irrevocably consent to the exclusive jurisdiction of courts located in Japan over any disputes arising from or in connection with this agreement.
