CBRNE Response Solutions and HBA System Integrators have agreed to work together to identify equipment and training solutions that will provide Chemical Biological Radiological Nuclear and Explosive (CBRNE) response capabilities to the Israeli Police Bomb Disposal Unit.

The Police Bomb Disposal Unit is developing requirements for this project at this time therefore, the program size is undefined as is the funding source. Without knowing these items, work share as well as the financial relationship between the 2 companies cannot be agreed to. Once these unknowns are defined, CBRNE Response Solutions and HBA System Integrators will define a business relationship that will allow them to effectively pursue the program.

Both CBRNE Response Solutions and HBA System Integrators have agreed to self fund any Business Development efforts so no funds have been exchanged nor will they be until the program is won. At that time, any compensation will be made according to the business agreement.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

CBRNE Response Solutions will work with HBA System Integrators to understand equipment and training requirements of the Israeli Police Bomb Disposal Unit to respond to CBRNE attacks.

CBRNE Response Solutions will brief US Government Agencies regarding the Israeli Police Bomb Unit requirements to see if there is interest in funding the Israeli program with the intent that the US Government can leverage proven elements of the program to meet US requirements.

When a program is defined and funding is available, CBRNE Response Solutions will identify potential US companies able to provide the equipment and training solutions that can be proposed in response to a tender. If CBRNE Response Solutions and HBA System Integrators win a program to provide a solution to the Israeli Police program, CBRNE Response Solutions will coordinate activities of US based team members.

If yes, describe all such political activities indicating, among other things, the relations, interests or policies to be influenced together with the means to be employed to achieve this purpose.

The Israeli Police may need funding support to achieve the objectives of their CBRNE program. There is interest in the Israeli Police Bomb Disposal Unit to create a collaborative program with the US that will benefit both countries by identifying and integrating CBRNE equipment and training into proven response systems.

CBRNE Response Solutions will identify US Agencies that could be potential partners for the Israeli Police CBRNE program and brief them on the proposed Israeli Police Bomb Disposal Unit concept to see if there is interest in participating in a program. If there are US Agencies which express interest in a joint program, CBRNE Response Solutions will provide this information to HBA System Integrators and the Israeli Police Bomb Disposal Unit. Participation by a US Agency may involve funding for the program as well as participation in planning and progress meetings which may not be in their current plans.
