AGREEMENT BETWEEN THE EMBASSY OF JAPAN
AND RSC SERVICES INTERNATIONAL LLC

This agreement summarizes the terms by which Minister and Head of Chancery of the Embassy of Japan in Washington, D.C. (EOJ), Kenichiro Mukai, representing EOJ, engages Raymond S. Calamaro, Manager and Member of RSC Services International LLC (RSCSI), to provide services as described below:

- Calamaro will continue to advise and support EOJ in connection with its dealings with the U.S. Congress and the U.S. Government.
- Such advice and support will include providing information and analysis on matters of interest to EOJ and other assistance as EOJ may request.
- If and as requested by EOJ, Calamaro will represent, or advocate on behalf of, EOJ.
- Calamaro will continue to assist EOJ by coordinating the efforts of the "EOJ Team," which comprises RSCSI and other firms that assist EOJ's Congressional Affairs Section.
- Calamaro will provide regular reports to EOJ on the activities he conducts pursuant to this agreement.


Following are additional terms that relate to this agreement:

- *Period of engagement*- This agreement shall take effect on April 1, 2020 and shall terminate on March 31, 2021, renewable by written agreement between EOJ and RSCSI. Either party shall have the right to terminate this agreement at any time, without cause, upon thirty (30) calendar days' written notice to the other party.
- *Fees*- RSCSI will bill EOJ \$ 23,833 per month (\$ 23,837 for the first month) for its services, including ordinary and customary out-of-pocket expenses (principally for local travel, business entertainment, long distance telephone and other communications, postage document reproduction and other expenses). Any additional expenses (i.e., out-of-town travel) incurred with EOJ approval will be billed monthly and shall be reimbursed promptly upon submission of a monthly statement to EOJ. EOJ will pay such bills, to the extent it considers them appropriate and justified, within forty days of their receipt.
