Rodney Dixon is a Barrister in London who asked me to assist in organizing a lecture about the affect of international law and human rights law on what is happening in Yemen. The lecture is meant to be academic in nature in that it will discuss how the law affects the situation and will consist of lawyers and professors as speakers at the event. Mr Dixon has asked me to help organize by contacting potential speaker, helping in booking the venue and catering and to do things like create a program to advertise the event. I've been instructed to start contacting some speakers, possible venues and sponsors to see if potential speakers are available at the end of June (June 25 or 26) when it is hoped the lecture could be held and venues to see if anything is available for that time period, and have made some contacts have been made. Funding is still in the process of being secured for the event, including costs and an amount to pay me for my work on organizing the event. I proposed fee of 8000 GBP has been suggested for compensation for helping organize the conference but needs confirmation of the exact amount once funds are secure.

I have been asked to contact potential speakers, sponsors for the event, possible venues, catering, organize any equipment needed (microphones, cameras etc), organize the program, and help with advertising the lecture.

As noted in the Short Form Registration Statement, the purpose of the event is to hold a lecture about how international and human rights law affects the conflict in Yemen, and I have been instructed that the event must bring all sides together to have a full discussion without advocating for any side or opinion over another. However, I answer Yes to this question, after speaking to FARA I was advised that because opinions might be expressed during the course of the lecture by speaker which might have an influence on those listening and their opinions of policies.
