**CONSULTING SERVICES AGREEMENT
AMENDMENT**

THIS AMENDMENT, effective January 1, 2024, shall amend that certain Consulting Services Agreement dated August 11, 2022, as amended (the "Agreement"), by and between:

Embassy of the State of Qatar (the "Embassy")

and

Blueprint Advisors LLC (the "Consultant")
4201 Yuma Street, NW
Washington, DC 20016
Attn: Mr. Chris Henick, Co-Chairman

In consideration of the mutual promises set forth herein, the Embassy and Consultant agree to amend the Agreement, as follows:

1. The Term of the Agreement shall be renewed for the period from January 1, 2024 through December 31, 2024, unless earlier terminated in accordance with the Agreement. The Term may be extended only upon execution of a written amendment, signed by authorized representatives of both parties.
2. Appendix B of the Agreement is amended by deleting Paragraph 1, and replacing it with the following:

"Consulting Fee: For the Services rendered pursuant to this Agreement, Embassy shall compensate Consultant as follows: US\$ 35,000. per calendar month. Payments shall be made on the last calendar day of each month during the Term."

Except as expressly stated herein, nothing in this Amendment shall alter or amend the terms of the Agreement.
