CONSULTING SERVICES AGREEMENT – AMENDMENT

THIS AMENDMENT is effective January 1, 2026, and shall amend that certain **CONSULTING SERVICES AGREEMENT** (the "Agreement") dated August 11, 2022, as amended, by and between:

Attn: Mr. Chris Henick, Co-Chairman


In consideration of the mutual promises set forth herein, the Embassy and Consultant agree to amend the Agreement as follows:

1. The Term of the Agreement shall be renewed for the period from January 1, 2026 through December 31, 2026 (the "Renewal Term"), unless earlier terminated in accordance with the Agreement. The Term may be extended only upon execution of a written amendment, signed by authorized representatives of both parties.
2. During the Renewal Term, the Consulting Fee shall be governed by the following:

"Consulting Fee: For the Services rendered pursuant to this Agreement, Embassy shall compensate Consultant as follows: **US\$ 35,000.** per calendar month (the "Consulting Fee"). Payments shall be made on the last calendar day of each month during the Term."

Except as expressly amended by this Amendment, all other terms of the Agreement shall remain unchanged. Without limiting the generality of the foregoing, the Consulting Fee and payment schedule shall remain unchanged.
