The nature of the work began to promote the 2022 World Cup in Qatar in the United States and Qatar. The understanding was expanded to include relationship-building with the leadership in the Jewish community in the United States to better international relations. Methods of performance included peaceful means of community engagement, charitable contributions and arranging meetings in the United States and visits to Qatar. The initial grant was for USD \$1.45 million for compensation, disbursements, and operating expenses.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The registrant began working to promote the 2022 World Cup in Qatar, and then expanded its activities to include fostering better international relations within the gulf region and with the leadership in the Jewish community in the United States. The registrant promoted the positive image and interests of the foreign principal through community organizations, charitable contributions, and encouraging lectures, visits and other speaking opportunities in the United States and Qatar.
