

- (3) Discussing indirect US-Iran talks on the nuclear deal in Vienna - Voice of America - April 6, 2021)
- (4) Meeting with Professor Edmund Ghareeb a Lebanese American scholar at Georgetown University, author of several books and research on the Kurds and Mr. John Saleh journalist and political researcher and discussing Kurdish national struggle in Iran and Kurdish advocacy and political strategy in D.C.
- (5) Meeting with Christopher C. Hull, a Senior Fellow at Americans for Intelligence Reform, and the President of Issue Management Inc, discussing JCPOI, the future of US-Iran relations and Kurdish conflict in Iran.
- (6) Discussing US-Iran relations with new Iranian President Ebrahim Raisi in power, the future of nuclear talks with Iran, sanction reliefs, Iran's ballistic missile capabilities, Shiia militias and Iran's adventurous policies in region on Kurdistan 24 TV station - June 23, 2021.
- (7) Attending an event of representatives of Kurdish parties, academists and scholars organized by Washington Kurdish Institute to discuss and update current Kurdish affaires in different parts of Kurdistan. June 24, 2021
