TRG Advisory Services, LLC engaged in the following activities on behalf of the Embassy of the United Arab Emirates:

Activity of this Period

TRG developed a podcast series entitled “Podbridge,” which covers emerging issues and ideas of shared interest in the U.S., the Middle East and around the world. TRG built Podbridge.com, the website that hosts the podcast, and continues to support the website by posting content, providing SEO and coding updates, adding new platforms and ensuring uptime via the hosting provider, WP Engine.

TRG was responsible for all aspects of production of the podcasts, including recording the podcast conversations with the host and guests, editing the podcast, creating promotional materials for each episode that included video clips of each conversation, and distributing the podcast to podcast platforms. TRG compiled metrics reports periodically for individual episodes and for the show overall and met with members of the Embassy staff to walk through those metrics. TRG also created advertisements to run in podcasts across the Acast advertising network for the Hope Mars Mission (A Reason for Hope) episode.

Podbridge.com and the landing page on each of the podcast platforms describe the podcast in substantially the following terms:

Podcast Name: Podbridge

Podcast Description and Disclosure: Podbridge covers emerging issues and ideas of shared interest in the U.S., the Middle East and around the world. Episodes will feature conversations with leading thinkers on topics such as science, technology, health, the environment, women’s empowerment and religious tolerance.
