National Council of Resistance of Iran	<p>The registrant provided counsel to and participated in strategy sessions with the foreign principal regarding how best to counter false narratives about the NCRI and how to improve the reach and effectiveness of NCRI efforts to expose Iran's sponsorship of terrorism, regional aggression, and its nuclear weapons program. The registrant also attended meetings with the foreign principal with various think tanks, as well as the National Defense University. In addition, the registrant co-signed: 1) an open letter on March 21 responding to an article in a French publication that was unfairly critical of Maryam Rajavi, the head of the NCRI; and 2) a joint letter to the Secretary of State on April 20 regarding the need to reject possible Iranian attempts to penalize the NCRI in the context of US-Iranian nuclear negotiations. The registrant further spoke at a Nowruz celebration in Washington, DC on April 4 and gave a presentation in Paris, France on April 23 on Iran's nuclear program and the need to establish a democratic government in Iran. Finally, the registrant published an op-ed on April 15 in The Washington Times regarding the denuclearization of Iran, and was interviewed on Newsmax on April 15 and June 29 and on The Washington Times' The Capitol Hill Show on May 14 regarding U.S. policy toward Iran.</p>

Appendix Response to Item 12-Description

National Council of Resistance of Iran: As described in the response to Item 11, the registrant attended meetings with the foreign principal with various think tanks, as well as the National Defense University. In addition, the registrant co-signed: 1) an open letter on March 21 responding to an article in a French publication that was unfairly critical of Maryam Rajavi, the head of the NCRI; and 2) a joint letter to the Secretary of State on April 20 regarding the need to reject possible Iranian attempts to penalize the NCRI in the context of US-Iranian nuclear negotiations. The registrant further spoke at a Nowruz celebration in Washington, DC on April 4. Finally, the registrant published an op-ed on April 15 in The Washington Times regarding the denuclearization of Iran, and was interviewed on Newsmax on April 15 and June 29 and on The Washington Times' The Capitol Hill Show on May 14 regarding U.S. policy toward Iran. The registrant did not engage in communications with U.S. government officials.
