CCTV, through a division it has named China Global Television Network ("CGTN"), offers multi-language news channels internationally, including a 24-hour English-language news channel that is broadcast to over 100 countries, including the United States.

CGTN America is the Washington news bureau for CCTV, which is a state-owned public institution of the People's Republic of China.

V. Informational Materials

11. Will the activities of the registrant on behalf of any foreign principal include the preparation or dissemination of informational materials?

Yes. The Department of Justice's FARA Unit has stated that "'bona fide news or journalistic activities' are not exempt from the statute's [*i.e.*, FARA's] reach unless they are undertaken by organizations in the United States that are controlled by U.S. citizens"; and that "the registration requirement does not depend on the accuracy of reporting, or the viewpoint (or viewpoints) expressed," but that it does depend on whether the organization "intends to influence the American public and policy makers on relevant topics" (termed "political activities" in FARA), "regardless of whether it is also 'balanced' or aims to balance reporting by other networks." In light of these considerations, the FARA Unit has concluded that CGTN America engages in "political activities" as defined by FARA, requiring it to register. The FARA Unit also has concluded that registration is required because CGTN America is acting as a "publicity agent" and "information-service employee," as those terms are defined in FARA. The FARA Unit has concluded that the news programs produced by CGTN America and broadcast internationally (including the U.S.) by CCTV/CGTN are "informational materials."
