INSTRUCTIONS. Privacy Act Statement. The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. As Deputy General Manager, filer works with the General Manager/Executive Deputy General Manager to implement management of MediaLinks TV, LLC (MediaLinks), which includes its news reporting and programming. As explained in response to item 11 in CGTN America's Registration Statement (now under the name MediaLinks), and in response to item 9 of the Exhibit B thereto, the Department of Justice's FARA Unit has stated that "'bona fide news or journalistic activities' are not exempt from the statute's [i.e., FARA's] reach unless they are undertaken by organizations in the United States that are controlled by U.S. citizens"; and that "the registration requirement does not depend on the accuracy of reporting, or the viewpoint (or viewpoints) expressed," but it does depend on whether the organization "intends to influence the American public and policy makers on relevant topics" (termed "political activities" in FARA), "regardless of whether it is also 'balanced' or aims to balance reporting by other networks." In light of these considerations, the FARA Unit has concluded that CGTN America (now known as MediaLinks TV) engages in "political activities" as defined by FARA.
