CCTV	<p>MediaLinks acts as the Washington News Bureau for CCTV, which through a division it has named the China Global Television Network (CGTN) offers multi-language news channels internationally, including a 24-hour English-language news channel broadcast in over 100 countries that includes the U.S. MediaLinks works in tandem with CGTN news bureaus in London, Nairobi, and Beijing to produce news programming for the 24-hour English-language broadcasts. MediaLinks strives to offer its audiences news coverage from a perspective that is not Western-centric. In so doing, MediaLinks performs its news gathering and reporting activities like those of other Washington news bureaus, including those of other foreign news organizations that broadcast or publish in the U.S. MediaLinks' news gathering and production activities are performed by professional journalists (mostly U.S. citizens). To enhance its coverage, MediaLinks and its affiliates also maintain commercial arrangements with a number of news services, including NBC News, CNN, Reuters, AP, and Agence France-Presse. MediaLinks' programs are transmitted to CCTV/CGTN in Beijing, which re-transmits the programs on its CGTN international channel to television broadcasters/cable providers for dissemination to local audiences around the world, including the U.S. The regular news programs produced by MediaLinks during this reporting period were as follows: World Today, Global Business, The Heat, China 24 (America), Full Frame, and Americas Now (all aired in the U.S during a designated time slot under the brand name "CGTN America"). MediaLinks also produced and distributed the following special programs during the reporting period: UN Insider, Big Story, Global Action Initiative, and 2024 In Review. MediaLinks' programs are treated as "informational materials" and submitted on DVDs to the FARA Unit monthly. MediaLinks also hosts websites and social media sites that are accessible in the US. These sites are listed at Section V, Item 18. In gathering, producing, and reporting the news, MediaLinks' journalists sometimes contact U.S. gov't officials and other media representatives for the exclusive purpose of collecting and confirming information for news programs. In addition, based on the topic of news coverage, MediaLinks also sometimes invites U.S. gov't officials, along with representatives of U.S. businesses, civic groups, and academic institutions, to appear as guests on its programs to comment on news developments. These invitations are extended to promote balanced and neutral coverage of the news. (Any appearances by U.S. gov't officials would be captured in the DVDs submitted monthly to the FARA Unit.) Finally, during the reporting period, MediaLinks engaged in the following promotional activities: (1) On Sept. 10, 2024, it held a panel discussion during NYC TV Week/Next TV Summit in NYC to promote its programs. (2) On Sept. 25, 2024, it distributed a 4-minute promotional video ("Written in the Sky: My China Story") on the NASDAQ & MiFi screens in NYC. (3) On Sept. 28, 2024, it hosted a forum in NYC to discuss China-U.S. cultural exchange and stories of friendship through youth study and exchange programs (a 1-minute & a 4-minute promotional video were distributed). (4) On Jan. 16, 2025, it hosted an event in NYC to celebrate the Lunar New Year, which included performances of live music, a fashion showcase, dance, and singing (a 1-minute and a 2-minute promotional video were distributed). (5) From Jan. 20 to Jan. 26, 2025, in collaboration with National CineMedia (NCM), it distributed a 30-second video promoting the Spring Festival Gala in the ticketing areas of certain theaters in San Francisco, Los Angeles, NYC, Washington, D.C., Chicago, Houston & Dallas. (6) From Jan. 20 to Jan. 26, 2025, in collaboration with Orange Barrel, it distributed a 30-second video promoting the Spring Festival Gala on the outdoor screens of the TCL Chinese Theatre in Hollywood, Los Angeles.</p>

Television audiences in over 100 countries, including the United States. More specifically, as previously explained, MediaLinks acts as the Washington New Bureau for CCTV. CCTV, through a division it has named the China Global Television Network ("CGTN"), offers multi-language news channels internationally, including a 24-hour English-language news channel that is broadcast to over 100 countries, including the United States. MediaLinks works in tandem with CGTN news bureaus located in London, Nairobi, and Beijing to produce news reports and other programming for the 24-hour English-language broadcasts. MediaLinks performs news gathering and reporting activities like those performed by other Washington news bureaus, including those of other foreign news organizations that broadcast or publish in the U.S.
