No consultancy and or representation services have been performed or delivered by The Interamerica Group on behalf of the foreign entity (The state of Amazonas – Brazil. Due to the fact, the parties never signed a contract and did not execute the proposed program filed on DOJ/ FARA registration, and there were no payments or any form.
