Since 2003, Berkman has provided legal services to Shurat HaDin-Israel Law Center ("Shurat") on a purely pro bono basis. We are not under any contractual obligation to provide any service to Shurat. We simply have an understanding that Shurat can ask us for legal advice and we will provide it if we have the time and inclination to do so. Shurat is a not for profit organization devoted to human rights, assisting victims of terrorism and their families, and prevention of terrorism. On occasion, Shurat has asked us to evaluate litigation options in the United States for the benefit of victims of terrorism and their families, usually American citizens. We have been retained by some of those American citizen terror victims and their families, either directly or through other attorneys, including Shurat founder Nitsana Darshan-Leitner, a noted Israeli human rights lawyer, to pursue litigation in the United States. This work may involve sending demand letters to potential defendants and making law enforcement inquiries with U.S. officials. Whether we choose to undertake those representations is up to us and our clients. Once retained, we make all litigation decisions on behalf of our clients in consultation with those clients. We may coordinate with Shurat if it is assisting the same clients, but we do not take direction from Shurat. Rather, our clients are our principals.
