Re: Terms of Engagement

Dear Mr. Bobokov:

We at the Alexandria Group International (the “Firm”) are pleased that you, your wife Hristina Nedyalkova Bobokova, and your brother Atanas Stoilov Bobokov (collectively, “you”) have chosen to continue the Firm’s assistance in representing your interests in Washington and in Bulgaria as those interests pertain to Bulgarian-U.S. bilateral relations. The purpose of this letter is to confirm the terms of our overall engagement. This engagement is effective October 15, 2021, and will continue in effect until April 15, 2021, unless otherwise agreed by the Firm and you. During our engagement, you agree to pay the Firm a monthly retainer fee of \$7500, for a total retainer amount of U.S. \$45,000. The first payment of \$7,500 is due on October 15, 2021. Subsequent \$7500 monthly payments shall be due on the 15th day of: November, 2021; December 2021; January, 2022; February, 2022; and March 2022. The Firm will issue invoices for each of these payments. The Firm will not bill separately for incidental expenses, but will bill monthly for any travel expenses or special projects (such as mass document production and transmission). Travel expenses by members of the Firm or other persons whom you designate and special projects must be approved in advance by you.

As with our second (January 1, 2021) and third and most recent (July 1, 2021) engagement letters, this letter incorporates the terms contained in paragraphs two, three, four, and five of the original Terms of Engagement Letter executed by the Firm and you on July 1, 2020. That original letter, including its list of activities that the Firm committed to undertake on your behalf, hereby becomes an integral part of this Terms of Engagement letter, which I have signed on October 15, 2021. To this primarily political agenda, we also agree to add the promotion of certain mutually agreed international business projects undertaken by your companies.


