Thanks for getting us all together and coordinating us on a call this week! It is very clear that the CGF has been leading us on with vague promises for quite a while now without delivering concrete action. Although the leadership committee has promised that they are responding to the asks in our coalition letter, it has been 6 months since we sent it and escalation seems warranted. We were thinking it would make sense for the coalition to send another follow up letter pushing the CGF leadership and steering committee companies (Mars, Mondelez, Target, Metro AG) to publish their action plan for 2020 ASAP, which could then build momentum leading into their June meeting. Perhaps we could also run an online campaign/petition targeting the leadership and steering committee companies between then as well that gets delivered at the June meeting.
