Hi Girish,

Thank you for the clarification. In your earlier email you stated that: *'all but one of our suppliers met those expectations by excluding Samling from their supply chain and the one exception represented a very small fraction of our supply (well below 1% of our total volume) and was closed out efficiently.'* However, it addition to KLK (who we understand is no longer sourcing from Samling) there are other points of potential entry of Samling palm oil into P&G supply chains:

1. As mentioned in our latest [Rapid Response report](#), Sarawak Oil Palms Bhd (SOPB) – listed in P&G's mill disclosure – is still sourcing from Samling. How is P&G addressing this with SOPB?
2. We have also learned that Genting - listed in P&G's mill disclosure - is also sourcing from Samling. We have talked to them directly and it looks as though they will be suspended them. You may wish to contact them to confirm directly.
3. One palm oil trader has told us that they believe Kwantas Corporation - listed in P&G's mill disclosure - is sourcing from Samling. Are you able to follow up on this?
4. Finally, we see that Tunas Baru Lampung (TBL) is listed in P&G's mill list. A number of traders have now suspended TBL, but not all. Please can you clarify if TBL is still in P&G's supply chain, and if so, through which trader(s)?

As Sarah mentioned, we are encouraging companies to adopt a formal “no-purchase” position on Samling and communicate this to all suppliers to minimize the risk of Samling's palm oil entering into supply chains. Given all of the above potential entry points of Samling palm oil into P&G supply chains, we believe it is important that P&G instruct all its first tier suppliers not to supply Samling oil to P&G's future supply chains (this is what Unilever and others are doing). This will help avoid Samling oil entering P&G's supply chain through other routes. Please let me know if a no-buy policy is something P&G will be implementing, or if P&G will continue to engage with suppliers regarding Samling on a case by case basis.

Thank you for your time, and I look forward to working together to create deforestation-free supply chains.
