Hi Nick,

Thank you for the responses. At this time, does Cargill plan to pursue any follow-up with any of the suppliers where you have supply chain links?

While your due diligence did not indicate illegal activity at the time of the formation of the business relationship, we have concerns particularly for Fazenda Triunfo and Fazenda Santo Cristo II, about the protection of the natural reserve Área de Proteção Ambiental do Rio Preto. Furthermore, Fazenda Floresta Ramada I, II, III, IV and V - Fazenda Califórnia is located in Matto Grosso, where [the latest Trase report](#) points out that 95% of the deforestation on soy farms from 2012-2017 was illegal under Brazilian law because the necessary licenses were not in place.

While it seems Cargill is only focusing on illegal deforestation at the moment, we still firmly believe that all of the cases of deforestation referred to in the Rapid Response reports need to be followed up on where there are supply chain links. Nevertheless, as the Trase report points out, the large majority of deforestation in Matto Grosso is illegal.
