



**CONSULTING SERVICES AGREEMENT

THIS AMENDMENT, effective January 1, 2024, shall amend that certain Consulting Services Agreement dated September 1, 2019, as amended (the "Agreement"), by and between:

In consideration of the mutual promises set forth herein, the Embassy and Consultant agree to amend the Agreement, as follows:

1. The Term of the Agreement shall be renewed for the period from January 1, 2024 through December 31, 2024, unless earlier terminated in accordance with the Agreement.
2. Appendix B of the Agreement is amended by deleting Paragraph 1, and replacing it with the following:

"Consulting Fee: For the Services rendered pursuant to this Agreement, the Embassy shall compensate Consultant as follows: US\$ 50,000 per month. Payments shall be made on the first calendar day of each month during the Term."

Except as expressly stated herein, nothing in this Amendment shall alter or amend the terms of the Agreement.
