Re: Amendment to Engagement to Provide Legal Counsel to the Embassy of the State of Qatar – Special Projects

Dear Sir:

This letter amends the March 26, 2020, engagement letter between Waltham PLLC and the Embassy of the State of Qatar in Washington, DC in respect of certain special projects.

The March 26, 2020, engagement letter is amended as follows:

Numbered paragraph 1 is amended to read as follows:

Qatar Hurricane Harvey Fund and Qatar Hurricane Ian Fund: Legal advice regarding gift agreements, contracts, and related transactions to assist victims of Hurricanes Harvey and Ian, including audit oversight and reporting, and legal assistance to the Embassy's operational team. Compensation shall be at the rate of \$785 per hour, plus expenses; provided that no more than 15 hours will be recorded in a single calendar month except upon prior written approval from Embassy.

Numbered paragraphs 2 and 4 are deleted.

A new numbered paragraph 2 shall be added as follows:

Litigation Monitoring and Advice: Monitoring and legal advice regarding U.S. litigation. Representation shall not include entry of appearance in any court proceeding. Compensation shall be at the rate of \$890 per hour, plus expenses; provided that no more than 15 hours will be recorded in a single calendar month except upon prior written approval from Embassy. Continuation of this matter after three months shall be subject to Embassy's written approval.

Numbered paragraph 3 is unchanged.

For the avoidance of doubt, these engagements do not include lobbying work.

All other terms of the March 26, 2020, engagement letter for special projects shall remain unchanged.
