

TRT has a 24-hour English language news channel called TRT World that is broadcast to approximately 80% of the countries in the world including the United States. As TRT's branch office in the United States, Turkish Radio Television Corporation works in tandem with other TRT World offices in Istanbul, Turkey and London, UK to produce news reports and other programming for the TRT World channel. Turkish Radio-Television Corporation performs news gathering and reporting activities like those performed by other news and broadcast organizations that are not controlled by foreign governments. Turkish Radio-Television Corporation engages a team of highly qualified professional journalists, editors and producers who are responsible for producing certain TRT World programs.
