Dear Ambassador Sandhu,

We are delighted that the Republic of India has agreed to establish a relationship with the Williams Group. Please accept this letter of Agreement ("Agreement") to work on your behalf.

Scope of Work: The Williams Group representation will encompass providing strategic counsel, tactical planning and government relations assistance on policy matters before the U.S. Government, the U.S. Congress, and select state governments, as well as academic institutions and think-tanks ("Services").

Fees and Term: In consideration for the Services provided by the Williams Group, the Republic of India agrees to pay the Williams Group a monthly fee of USD 15,000 for services beginning October 1, 2020 through March 31, 2021.

Termination and Cancellation: Either the Williams Group or Republic of India may terminate the Agreement for any reason upon ninety (90) days written notice, with no further obligation, other than to pay such fees that have accrued up to and through 90-day notice period.

Confidentiality: The Williams Group recognizes that in the course of our representation, we could become aware of information, practices or policies, which you wish to be kept confidential. The Williams Group agrees to maintain that confidentiality and will not disclose to any outside party the information either during the period of a contract or afterwards, to the extent permitted by law.



Entire Understanding: This Agreement contains the entire understanding between the parties. Amendment, modification or waiver of this Agreement may be accomplished with a written instrument signed by both parties.

Please sign this Agreement and return the countersigned copy to us. We look forward to continuing our relationship with the Republic of India.
