We are delighted that the Embassy of Sudan has agreed to engage the Williams Group. Please accept this letter of Agreement ("Agreement") to work on your behalf.

**Scope of Work:** The Williams Group representation will encompass providing strategic counsel, tactical planning and government relations assistance on policy matters before the U.S. government, the U.S. Congress as well as think-tanks ("Services").



**Fees and Term:** In consideration for the Services provided by the Williams Group, the Embassy of Sudan agrees to pay the Williams Group a monthly fee of USD 60,000 for services beginning January 1, 2026 through December 31, 2026.

**Termination and Cancellation:** Either the Williams Group or Embassy of Sudan may terminate the Agreement for any reason upon thirty (30) days written notice, with no further obligation, other than to pay such fees that have accrued up to and through 30-day notice period.

**Confidentiality:** The Williams Group recognizes that in the course of our representation, we could become aware of information, practices or policies, which you wish to be kept confidential. The Williams Group agrees to maintain that confidentiality and will not disclose to any outside party the information either during the period of a contract or afterwards, to the extent permitted by law.

**Entire Understanding:** This Agreement contains the entire understanding between the parties. Amendment, modification or waiver of this Agreement may be accomplished with a written instrument signed by both parties.
