## **AGREEMENT FOR THE PROVISION OF BUSINESS SUPPORT AND RELATED SERVICES**

1. This Agreement, by and between The Ogilvy Group, LLC, a company incorporated under the laws of the USA (herein referred to as "Service Provider") and Memac Ogilvy and Mather LLC – Abu Dhabi Branch, Abu Dhabi Mall Building, Al Zahlyah, Abu Dhabi, UAE a company incorporated under the laws of United Arab Emirates (hereinafter referred to as "Service Recipient").
2. This Agreement has effect from 16<sup>th</sup> April 2024 as agreed.
3. The objective of this Agreement is to set out:
  - a) the provision of business support and related services as described in Schedule 1 ("Scope of Work & Fees") including but not limited services supporting the business operations of the Service Recipient;
  - b) the service fees (herein referred to as "Fees") to be charged by the Service Provider for the rendering of these services.

### **4. Remuneration for Services**

Effective from the date in Clause 2, the Service Provider will charge the Service Recipient a Fee. The quantum of the Fees appropriate for these services are determined in accordance with Schedule 1 (Scope of Work & Fees) of this Agreement.

### **5. Compensation and Terms of Payment**

The Service Provider will invoice the Service Recipient and the Service Recipient shall pay for the Services in accordance with the following:

- a) The Fees shall be determined and invoiced by the Service Provider in accordance with Schedule 1;
- b) Billing will be based on the actual timesheet within the budgeted fees listed in Schedule 1. Any additional time that exceeds the budget will not be considered. The timesheet must be submitted by the Service Provider after it has been reviewed and approved by the regional project manager. The Service Provider will provide detailed timesheet records to the Service Recipient, outlining the services performed and the time spent on each task.
- c) A Purchase Order (PO) will be issued by the Service Recipient only after the opening of a PO line by the Client (DCT). The Service Provider will issue invoices only after receiving the PO.
- d) Payment will be due upon receiving payment from the Client.
- e) The Service Recipient will retain an amount equivalent to 10% of the value of each of the Service Charge invoices, net of VAT, submitted by the Service Provider under this Agreement. The Service Recipient is entitled to liquidate the 10% retention amount in case the Service Provider fails to fulfil any of its obligations hereunder which is not remedied by the Service Provider within (30) calendar days after the service by The Service Recipient of a written notice on the Service Provider specifying the nature of the breach and requiring such breach to be remedied. The 10% retention amount will only be released upon fulfilment of all obligations by the Service Provider pursuant to this Agreement to The Service Recipient's satisfaction.

**6. Supporting Documentation**

The Service Provider shall make support related to the underlying Fees available to the Service Recipient on request. The Service Recipient shall have the right to inspect, during normal business hours, and upon reasonable advance notice, such books, records and other supporting data of the Service Provider's service center as may be reasonably necessary to verify the Service Provider's computation of the Fees.

All data disclosed in accordance with this Agreement shall be subject to corporate internal policies with respect to data, privacy and confidentiality. Documents should be retained in accordance with local regulation where applicable or in accordance with corporate policy.

**7. Disputes**

Where any dispute arising out of or in connection with this Agreement, including any question regarding its existence, validity or termination, arises (a "Dispute") the Service Provider and Service Recipient shall attempt, in good faith, to resolve the Dispute in the first instance. If the Dispute cannot be resolved, it shall be referred for final settlement to the ultimate parent company (WPP plc) Chief Financial Officer (or, if such person in that position is not available, an appointed deputy or appropriate delegate), who shall consider the Dispute and make a final determination on the matter as soon as practicable of such referral.

**8. Taxation**

The parties to this Agreement foresee that withholding and other income taxes will not be payable in relation to the services to be rendered under this Agreement as the Service Provider will qualify for an exemption. The parties to this Agreement will render each other full assistance in obtaining, maintaining and applying such exemption.

Should the Service Recipient be required to withhold tax under the laws and regulations of and applicable treaties entered into by the tax jurisdiction / country of the Service Recipient from any amounts due under this Agreement, the Service Recipient shall make such withholding and account to the competent tax authority in respect of the amount withheld within the timetable laid down by law following the date of payment of the net fee to the Service Provider. The Service Recipient shall deliver to the Service Provider an official receipt evidencing the payment of such taxes.

If legally required, any VAT or similar levies are to be paid by service Recipient in addition to the fee. The Service Provider is to issue invoices in line with the applicable tax law.

**9. Independent Relationship**

Neither party shall make any contract or representation or incur any obligation in the name or on behalf of the other party. Nothing in this Agreement shall be construed as appointing, or constitute the appointment of, either party as the agent of the other.

**10. Duration**

This Agreement shall be effective as specified in Clause 2 and shall have a duration of three years. It shall not renew automatically and shall terminate at the end of its specified duration without any further notice required from either party.

**11. Governing Law**

This Agreement shall be governed by and construed in accordance with United Arab Emirates Law.

**12. No Waiver**

In case of breach by either party of any provision in this Agreement, the party's continued dealing with the other party following a breach shall not be deemed to be a waiver of that provision.

**13. Entire Agreement**

The Agreement sets out the entire agreement between the Service Provider and Service Recipient and supersedes any prior agreements or understandings between the parties. In the event the Agreement is translated into any other language, the English language version shall prevail over any inconsistent interpretation

**14. Counterparts**

The Agreement may be signed in any number of counterparts, each of which shall be on original, with the same effect as if all signature pages were on the same instrument. Facsimile or electronically scanned counterpart signatures to the agreement shall be acceptable and binding.
