The Swedish Industries Fund has appropriated to the Swedish Travel Information Bureau, Inc. an additional amount of \$580.75 as final payment of the editing of the two black and white educational films on Sweden entitled DAY WITH THE KING and SWEDEN'S WARTIME ADJUSTMENT and also miscellaneous expenses in connection with our distribution.

The Swedish Traffic Association has granted to the Swedish Travel Information Bureau, Inc. an appropriation of \$10,000.00 annually to apply from July 1, 1943, for general expenses. This sum was previously \$5285.72 but is now increased in order to eliminate the necessity of covering shortage in the budget of the Bureau from other sources, such as the Swedish Industries Fund and the American Swedish News Exchange.
