## Appendix Response to Item 5

**Item 5: Each item checked above must be explained below in full detail together with, where appropriate, specific reference to and identity of the item in the registration statement to which it pertains.**

Registrant is amending the foreign principal name to reflect a change in the contractual relationship. Previously, registrant provided survey research services to The Kingdom of Saudi Arabia as a subcontractor through Qorvis Holding Inc. (formerly Qorvis Communications). Qorvis Holding Inc. is no longer under contract with The Kingdom of Saudi Arabia for the survey research work performed by the registrant.

Registrant now has a direct contractual relationship with the Embassy of the Kingdom of Saudi Arabia for the same type of survey research services (quantitative surveys on American attitudes and perceptions of Middle East and current event issues).

Accordingly, the foreign principal name is being amended from "The Kingdom of Saudi Arabia (through Qorvis Holding Inc.)" to "The Kingdom of Saudi Arabia."  
Registrant will also file an amended Exhibit B to reflect the new direct agreement with the Embassy.
