Registrant is filing an amended Exhibit B to reflect a new agreement with the foreign principal. The previously filed Exhibit B documented a subcontractor arrangement whereby registrant provided survey research services to The Kingdom of Saudi Arabia through Qorvis Holding Inc. (formerly Qorvis Communications). That arrangement has ended.

Registrant has entered into a direct agreement with the Embassy of the Kingdom of Saudi Arabia for survey research services. The new agreement (Statement of Work #K-254, dated November 2025) provides for quantitative survey research on American attitudes and perceptions of Saudi Arabia and related current events, continuing the same type of work previously performed under the Qorvis subcontractor arrangement. The executed agreement is attached hereto as the amended Exhibit B.
