

## FEDERAL LEGISLATION AND POLICY MATTER AGREEMENT

This agreement summarizes the terms by which Tiber Creek Group, Inc. (TCG) engages Patrick Griffin to assist with TCG representation of the Minister and Head of Chancery of the Embassy of Japan (the Embassy):

- TCG engages Patrick Griffin to advise it in this matter.
- Patrick Griffin undertakes to advise TCG and perform all of its activities pursuant to this agreement (i) according to the standards set forth in the applicable Rule of Professional Conduct (ii) in accordance with all applicable laws, rules and regulations, including the Congressional gifts and ethics rules, and (iii) in a manner that reflects favorably on the reputation and good will of TCG's client the Embassy of Japan.
- Unless the law requires the release of confidential information, TCG agrees to keep confidential during the period of engagement and thereafter, all information TCG learns about the Embassy, its staff, and its operations.
- Special terms that relate to this matter:
  - **PERIOD OF ENGAGEMENT.** TCG's engagement of Patrick Griffin in this matter shall be deemed to have begun on April 1, 2026, and shall terminate on September 30, 2026, renewable by written agreement between TCG and Patrick Griffin. Either party shall have the right to terminate this agreement at any time, without cause, upon thirty (30) calendar days' written notice to the other party.
  - **SERVICES AND REPORTS ON ACTIVITIES.** Patrick Griffin will provide services as instructed by TCG. Services will include advising TCG's client the Embassy on legislation in the U.S. Congress, and actions and policies of the Executive Branch and U.S. Government agencies, of interest to the Embassy. Patrick Griffin will, as appropriate, report to TCG's client, the Embassy, on all the activities it conducts pursuant to this agreement.
  - **FARA REGISTRATION.** TCG acknowledges that Patrick Griffin's representation of TCG's client, the Embassy, requires Patrick Griffin to register and report its representation with the Department of Justice pursuant to the Foreign Agents Registration Act ("FARA"). TCG further acknowledges that pursuant to Patrick Griffin's reporting obligations under FARA, Patrick Griffin will be disclosing this Agreement with TCG's representation of the Embassy as well as a description of its activities, all payments made to Patrick Griffin in connection with this representation, and all disbursements made by Patrick Griffin in connection with this representation, which will all be filed with the Department of Justice and made publicly available.


- **FEES.** Patrick Griffin will be paid Two Thousand US Dollars (\$2,000.00) per month. These fees will include compensation for Patrick Griffin's ordinary and customary out-of-pocket expenses (principally for local travel, business entertainment, phone and other communications, postage, document reproduction and other expenses). Any additional expenses (i.e., out-of-town travel) incurred with TCG's, and its client, the Embassy's approval will be billed monthly and shall be reimbursed promptly upon submission of a monthly and shall be reimbursed promptly upon submission of a monthly statement to TCG. TCG will pay such bills, to the extent it considers them appropriate and justified, within thirty days of their receipt.
