

## **Appendix Response to Item 5**

Brunswick would like to amend 14(a) in its Supplemental Statement for the 6 month period ending 11/30/2025 to include the information contained in the accompanying appendix.

Brunswick terminated its relationship with foreign principal XRG P.J.S.C. ("XRG") on 10/31/2025 for the particular FARA registrable mandate. This termination was reported on 12/26/2025 in Brunswick's December 2025 supplemental filing. As reflected here, Brunswick received a payment totaling \$3,501.92 from XRG on 4/2/2026 for work performed in September 2025 when the XRG registration was still active. This payment was not originally reflected in Brunswick's December 2025 supplemental filing as the payment had not yet been received during that reporting period.

The payment was received on 4/2/2026 from Foreign Principal XRG P.J.S.C. post-termination, in the amount of USD 3,501.92.
