Brunswick Group and XRG P.J.S.C. have agreed to an amendment regarding the fee terms of the Memorandum of Understanding executed July 10, 2025 and filed with the FARA Registration Unit on July 11, 2025. This amendment relates solely to Brunswick's engagement with XRG P.J.S.C. during the period in which Brunswick was actively registered. Brunswick's work for XRG P.J.S.C. concluded on October 31, 2025, as reflected in Brunswick's supplemental statement filed on December 26, 2025.

9. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

During the period of active registration Brunswick provided XRG P.J.S.C. limited strategic communications support. The scope of work comprised preparing briefing materials, media monitoring, general research, and logistics support. The attached fee amendment reflects a change in the nature of work required and performed under the previously filed Memorandum of Understanding, as described above.

THIS AMENDMENT is executed on December 24 2025

BETWEEN:

- (1) **XRG P.J.S.C.**, a company existing under the laws of the Emirate of Abu Dhabi and whose principal address is Al Sarab Tower, Abu Dhabi Global Market Square, Al Maryah Island, Abu Dhabi, United Arab Emirates (“**XRG**”); and
- (2) **BRUNSWICK FZ LLC**, a company duly established and existing under the laws of Abu Dhabi and whose registered office address is Level 6, Tower 4, Yas Creative Hub, Yas Island, P.O. Box 77800, Abu Dhabi, United Arab Emirates (the “**Brunswick**”),

each a “**Party**” and together the “**Parties**”.

NOW, THEREFORE, it is agreed as follows:

- 1. XRG and Brunswick entered into a memorandum of understanding on or about July 10, 2025 (the “MOU”).
- 2. The MOU provided for a fee to Brunswick of \$60,000 USD, to be paid monthly on a pro-rata basis over the term of the engagement, for services that Brunswick was to provide relating to the proposed aquisition by a consortium led by XRG of Santos.
- 3. As XRG and the consortium withdew their proposal to acquire Santos, and Brunswick did not perform a significant portion of the work contemplated in the MOU, Brunswick and XRG have agreed, on a non-precedential and non-quotable basis, that the \$60,000 fee set out in the MOU will not be charged to XRG and that XRG will not pay any amounts to Brunswick in connection with the MOU.


