### **Response to Item 12-Description**

Department of Culture and Tourism - Abu Dhabi: No Political Activity

London Legacy Development Corporation: Preparation of informational materials, including press releases and conversations with certain members of the press, in order to support the operations of East Bank and the partner institutions within the development. This has included outreach to the U.S. media. Brunswick notes that it circulated certain informational materials on February 28, 2024 that were mistakenly not labeled as required under FARA. Brunswick re-circulated the correctly labeled informational materials on March 28, 2024. Because Brunswick re-circulated the correctly labeled documents, it later answers "yes" to Question 22: "Has the registrant labeled each item of such informational materials with the statement required by Section 4(b) of the Act?"
