Pursuant to the Foreign Agents Registration Act of 1938, as amended

INSTRUCTIONS. Each partner, officer, director, associate, employee, and agent of a registrant is required to file a short form registration statement unless he engages in no activities in furtherance of the interests of the registrant's foreign principal or unless the services he renders to the registrant are in a secretarial, clerical, or in a related or similar capacity. Compliance is accomplished by filing an electronic short form registration statement at <https://www.fara.gov>.

Privacy Act Statement. The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. Statements are also available online at the FARA Unit's webpage: <https://www.fara.gov>. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Attorney General also transmits a semi-annual report to Congress on the administration of the Act which lists the names of all agents registered under the Act and the foreign principals they represent. Engage in civil, criminal and administrative litigation before the federal and state courts and agencies of the United States on behalf of the Republic of Turkey; provide legal advice to the Embassy of Turkey regarding the interpretation and applicability of U.S. federal and state law, legislation and policy; assist the Embassy in developing strategies to respond to legal claims against it and claims it may make in the U.S.; advise the Embassy in bilateral judicial and mutual legal assistance matters, including assisting in the research and preparation of responses to inquiries from the U.S. government and state governments; advise the Embassy concerning the functioning of its diplomatic mission in the U.S., including its consulates; advise the Embassy regarding the rights of its nationals in the U.S.; and monitor litigation in the courts of the U.S. that may impact the rights, privileges and immunities of Turkey. Advice will be provided in oral and written form, subject to the attorney-client privilege.
