Other positions on the National Executive Committee are currently vacant. Local chapters may be formed by interested volunteers in various states throughout the U.S., with approval from the President and Organizing General Secretary. Local chapters which are organized pursuant to Registrant's governing documents conduct activities under the direction of the President, Organizing General Secretary, or other members of the National Executive Committee (if and when filled).
