



Mr. McNamara,

OCP S.A. requests that OCP N.A. coordinate and direct activities necessary to respond to investigations by the U.S. Government related to countervailing duties, pursuant to a petition filed by The Mosaic Company regarding phosphate fertilizer imports.

These activities may include, but are not limited to:

- Developing and executing communications strategies about the phosphate fertilizer industry and market within the United States;
- Developing and executing engagement strategy with customers of OCP N.A., trade groups, and other third parties as needed;
- Interacting with investigative bodies;
- Governmental lobbying; and
- Management of media relations.
