Addendum to the Contractor Agreement Between the Haiti Embassy in Washington D.C. ("CLIENT") and the Latin America Advisory Group, LLC a Delaware Limited Liability Company ("CONSULTANT") on this 12th day of January, 2022

NOW, THEREFORE, in consideration of the promises and mutual agreements herein, CLIENT and Consultant agree to the following changes to the original contract signed:

- 3. Fees
 - a) Retainer Payment.
