

### **Response to Item 12-Description**

Xinhua News Agency: Xinhua News Agency North America reports news events in the United States for its Chinese and global audiences through Xinhua News Agency's global news services. The Department of Justice has stated that "[w]ith respect to foreign media organizations such as Xinhua North America, the registration requirement does not depend on the accuracy of the reporting, or the viewpoint (or viewpoints) expressed in it but rather on whether the organization intends to influence the American public or policy makers on relevant topics such as U.S. policy or foreign relations" (the definition of so-called "political activities" under FARA). In light of these considerations, the Department of Justice's FARA Unit has concluded that Xinhua North America's activities constitute political activity for purposes of FARA.
