CITGOH understands that under the DOJ's interpretation of FARA, PDVSA's indirect ownership of CITGOH, in itself, may render CITGOH an agent of the PDVSA Ad Hoc Board. Please note that CITGOH has indicated the relevant communications relating to its political activity on this registration.
