



The Ad Hoc Board of Petróleos de Venezuela, S.A. ("PDVSA Ad Hoc Board"): PDVH has participated in meetings with representatives of the U.S. Government and prepared materials for those meetings in an effort to protect the assets of PDVH and its subsidiaries from seizure or diminution in value by creditors of the Maduro regime. PDVH understands that under the DOJ's interpretation of FARA, PDVSA's indirect ownership of PDVH, in itself, may render PDVH an agent of the PDVSA Ad Hoc Board. Please note that PDVH has indicated the relevant communications relating to its political activity on this registration. Any political activity that has taken place without the participation of the registrant, specifically, through vendors, is not reflected on this filing but instead will be reflected on those registrants' supplemental registrations.
