Public Briefing

In recent months, Asayish (**Kurdistan Region Security Agency**) and partner agencies had deployed intelligence assets to verify reports of a concerted campaign directed by **Lahur Shex Jangi (Lahur Jengi Burhan)** and **Mr. Azhi Amin (an officer of the Kurdistan Region Security Council)** to create instability in the city and wider province of **Sulaymaniyah**. The stated aim of this campaign was to create public disorder and civil unrest through violence and incitement including the targeting of security personnel, public servants and political figures. The collection of evidence, intelligence assessments and the apprehension of individuals linked to the campaign has since corroborated reports received by security agencies. Subsequently, court-issued arrest warrants have been granted for individuals believed to lead and coordinate this campaign including **Lahur Jangi Burhan**. Initial attempts to execute arrest warrants by **Sulaymaniyah Police** and **Asayish (Kurdistan Region Security Agency)**, were met by intimidation and threats including the mobilisation of an armed militia and the display of heavy weaponry in residential areas of **Sulaymaniyah**. Deemed a high-security risk situation which could escalate and spread to other population areas of **Sulaimaniyah**, the Kurdistan Region Security Agency requested support from partner agencies which then mobilised to contain the movement of the armed militia in **Sulaimaniyah**.

In the early hours of **Friday 22nd of August**, the armed militias of **Lahur Jangi Burhan** opened fire on the personnel of the Kurdistan Region's security agencies as they attempted to act on a court-issued arrest warrant against **Mr. Lahur Jangi Burhan (the accused)**. The armed exchange resulted in the death and injury of a number of Kurdistan Regional Government security personnel, the destruction of property and the endangerment of the public. In addition, equipment intended for the campaign of violence was deployed against residential and security sites, including **Fermandaey (military base)** and the residence of **Mr. Bafel Talabani** which was targeted by several suicide drones in a manner reflective of terrorism. This briefing outlines the events preceding **22 August**, the first phase of the investigation which resulted in the issuance of arrest warrants and subsequent conclusions derived from testimonies of suspects and analysis of evidence. These events have confirmed an irrefutable attempt at creating public disorder and insecurity through direct and indirect actions including the attempted assassination of the **President of the Patriotic Union of Kurdistan, Mr. Bafel Talabani**.

Mr. Lahur Jangi Burhan has since been apprehended and charged with the crimes under **Article 56 of the Iraqi Penal Code** as the leader instigator and mastermind of the following events. As part of the ongoing investigation, the **Kurdistan Region Security Agency** and its partner organisations led by **Kurdistan Region Security Agency** officials are currently reviewing and analysing further evidence recovered at the compound of **Mr. Lahur Jangi Burhan** subsequent to the execution of arrest warrants and the apprehension of additional suspects.

In addition, sites implicated within the campaign of destabilisation including the assassination attempt have been secured with evidence undergoing continued analysis. This briefing has been compiled from the following sources:

- Testimonies of apprehended suspects including that of **Mr. Lahur Jangi Burhan**.
- Discovery and analysis of equipment intended for use during the assassination plot including suicide and surveillance drones, small and heavy weaponry and suppressed sniper rifles.
- Forensic analysis of electronic devices.
- Targeted surveillance and monitoring.

While investigations are ongoing, this briefing has been released to preserve the public interest and address a wide-spread mis-information campaign dedicated to creating instability in the interest of linked parties. As a security agency responsible for the preservation of stability and civilian life, we are determined to conduct our actions in the interests of the people of **Sulaimaniyah** and the Kurdistan Region within the complete legal guidelines. We are confident the expectation of the citizens we have a duty to protect is to prevent the presence and spread of armed gangs who act with impunity.

Incitement and endangerment of the public

- In recent months, **Mr. Lahur Jangi Burhan** has made a concerted effort to incite disorder and instability through public threats against authorities and intimidation of civilians and public servants, including asking people to commit acts of violence against the authorities.
- These actions include the build-up of a visible and illegally armed militia which he personally confirmed in an interview to media on **21 August 2025** in the central residential areas of Sulaymaniyah. The militia belonging to **Lahur Jangi Burhan** had illegally acquired and stockpiled small-arms and heavy weaponry including RPG's and suicide drones – with examples on visible display in residential areas of **Sulaymaniyah** and subsequently used against Kurdistan Region Government Security personnel and **Dabashan** compound on the morning of **22 August 2025**.
- Alongside intimidation of authorities, **Lahur Jangi Burhan** had made direct threats of violence against members of the public. One prominent recent example being against public servants on **18 May 2025** where he publicly declared a threat to life should the **Sulaymaniyah** local government approve investment projects in the proximity of **Newroz Football Club** without his approval.

Targeted Assassination of Mr. Bafel Jalal Talabani

- On **August 19, 2025**, two individuals in a vehicle were spotted acting suspiciously on the **Malik Mahmood Road** by an advance scout team of **Mr Talabani's** security detail and reported to authorities.
- With already heightened security measures in place due to earlier intelligence reports of mobilisation of armed groups, the suspicious vehicle and its occupants **Omar Sheikha Abdullah Sheikha** and **Ramadan Hussein Aziz Yousif** (occupants one and two) were then surveilled by **Kurdistan Region Security Agency** personnel for a number of hours.

Preparation for the attempted assassination

- Intelligence gathered by the **Kurdistan Region Security Agency** and partnered agencies has concluded that the assassination attempt had been in play for a prolonged period and was ongoing until the aim would be achieved. In one message exchange between the apprehended members of the surveillance units, it was stated *“last night he escaped from us, stay focused so he doesn’t escape today.”*
- In addition to the direct targeting of **Bafel Talabani’s** vehicle, our intelligence has since identified a **Sniper Observation Post** located within the apartments of **German Village** residential compound in direct line of sight of **Mr. Talabani’s** residence. **Exhibit 2**
- Contributing to this assessment, our investigating officers had secured intelligence on a series of sniper training activities involving **Mr Lahur Jangi Burhan**, **Pollad Shex Jangi** and an accused collaborator and coordinator (**Mr. Rebwar Qudrat**) of the assassination attempt, who was a sniper training specialist at one of the Kurdistan Region security agencies. **Qudrat** was identified as one of the handlers of the surveillance units. **Exhibit 3**
- Following the events of **22 August**, further investigation of drone activity reported over **Dabashan** (**Mr. Bafel Talabani’s** residence) and the Erbil residence of the **Deputy Prime Minister** between **10 August 2025 – 22 August 2025** and suspect questioning, it was also discovered that an arsenal of surveillance and suicide drones was developed with the intention of using this to execute the assassination plot and wider campaign of destabilisation.
- Possession of this equipment was displayed during the **22 August** assault on Kurdistan Region security personnel and parallel assault on **Dabashan** and **Fermandaeey**. In addition, direct evidence of equipment has been secured at sites implicated in the assassination plot including at residential properties within **City Towers** and **Hawari Jwani Tower**. An additional cache of weaponry has been discovered with in the **Shari Jwan** residential complex within immediate proximity of population areas including a popular hotel. **Exhibit 4**

- Intelligence assessments have since established a direct link between the supply of equipment, personnel, training and strategising of the assassination attempt to **Mr Azhi Amin**, a senior **Kurdistan Region Security Council** official based in Erbil. Notably, **Mr. Amin** was implicated as the lead coordinator of the threat to attack the **Erbil** residence of the **Deputy Prime Minister** in 2022.
- Joint investigations by the **Kurdistan Region Security Agency** and partner agencies have determined these actions to have been a part of a concerted effort to cause public disorder and instability in order to achieve political and military aims targeted at Kurdistan Region security personnel, the Patriotic Union of Kurdistan and the leadership of **Mr. Bafel Talabani**.
- The **Kurdistan Region Security Agency** had also secured intelligence from two meetings (**July and August 2025**) involving **Azhi Amin** and **Lahur Jengi Burhan**. Initially, the discussions were centred around the take-over of key **PUK** and security-related locations including **Dabashan** and **Qalachwalan** with the involvement of **Mr. Pollad Jengi Burhan** and supported by forces recruited and coordinated by **Azhi Amin** as the **Kurdistan Region Security Council**. Intelligence from a subsequent gathering in **mid-August 2025** had reported **Mr. Azhi Amin** concluded “**Bafel must be eliminated.**”
- Actions contributing to this effort included the illegal smuggling and distribution of small and heavy arms to supporters in and around **Sulaymaniyah** by **Mr. Lahur Jangi Burhan** with the direct support and coordination of **Mr. Azhi Amin**. This includes the development of suicide drones which were deployed against political, military and civilian infrastructure on the **22 August 2025**.
- Alongside the distribution of weaponry, our intelligence has confirmed training, and mobilisation was coordinated with the support of **Mr. Azhi Amin** who had provided recruits of **Mr. Lahur Jangi Burhan** instructors and training facilities within **Kori Village, Erbil** from **9th August 2025**. This event was considered to be the deployment briefing for the armed cell which received its initial instructions including the assassination of personnel from the **Kurdistan Region Counter-Terrorism Group**.

- Surveillance monitoring by the **Kurdistan Region Security Agency** confirmed additional efforts of mobilisation of armed gangs on the 17th, 18th and 19th August. These preparations were directly commanded by **Mr. Lahur Jangi Burhan** and coordinated with the support of two additional suspects: **Mr. Dilshad Abdullah, Mr. Aso Shex Jangi**.
- The build-up of armed gangs within the residential areas of **Sarchinar** which preceded the issuance of the subsequent arrest warrant became a significant cause for concern due to public safety. Our intelligence has concluded should an arrest warrant had not been requested, and support from partner agencies not deployed, **Sulaymaniyah** would have faced a significant security threat which would have resulted in significant loss of life and danger to the public.
- Suspect testimonies made to the investigating judge by apprehended suspects including that of **Lahur Jangi Burhan**, has confirmed the assessments reached by the investigating agencies. In addition, **Lahur Jangi Burhan** has confirmed to the investigating judge the critical role of **Mr Azhi Amin** in the campaign to launch assaults on Kurdistan's Region security personnel and the assassination plot against **Mr. Bafel Talabani**.
- A number of senior figures within the armed gangs recruited by **Mr. Lahur Jengi Burhan** and **Mr. Azhi Amin**, including those involved in the assault on Kurdistan Region security personnel are believed to have escaped and are currently being given safe haven by **Mr. Azhi Amin**.
- Given the overwhelming evidence collected on the role of **Mr. Azhi Amin** within the campaign to destabilise the security of the **Sulaymaniyah** province, and the attempted assassination of **Mr. Bafel Talabani**, the court has issued arrest warrants for **Mr. Azhi Amin** as well as other officers from **The Kurdistan Region Security Council**.
